Madam/Sir,

As you might be aware that Ministry of MSME, Government of India has brought Public Procurement Policy, 2012 as marketing support to the MSEs of the country. According to this policy all the Central Govt. Departments/Ministries and Central Public Sector Undertakings have to procure 20% of the annual requirements of store items including services from Micro, Small sector and 4% of the total requirement from Micro and Small sector owned by SC/ST entrepreneurs. The policy has become mandatory from 1st April, 2015 and accordingly all Ministries/Departments/CPSUs are bound to fulfill the requirements of guidelines of the policy.

2. Accordingly this Institute has to organize Two days National Vendor Development programme cum Industrial Exhibition at Patna in the month of February, 2016 wherein Central Government Departments/Ministries and CPSUs located in the state of Bihar and MSEs manufacturing various industrial items and providing services will be participating in the said event.

3. The objective of this event is to highlight about the items and services procured by buyers from displaying products and designs and the items/services manufactured/delivered by the MSEs from different parts of the country showing their capabilities and abilities to fulfill the requirements of the buyers. In this way the genuine MSEs/Vendors can also be identified to fulfill the procurement targets according to the public procurement policy.

4. The entire expenditure for organizing the said event will be borne by this institute. 55% of the total expenditure has to be generated as revenue according to the sanction guidelines.

5. Accordingly, it has been decided to generate revenue through stall charges of Rs.20000/- from Govt. departments, Commercial banks and Central Public Sector undertakings / large units. The MSEs has to pay Rs.6000/- as stall charges.

6. All the participating organizations/MSEs will be provided furnished stall (3x3 metres size) with one table, two chairs and lighting facilities. Each stall holders will be provided working lunch coupon and tea/snacks (morning and evening) for two persons for two days.

7. The participating departments/PSUs are requested to give their consent of their participation along with Demand Draft/Cheque for Rs.20000/- in favour of Director, MSME-DI payable at Patna.


