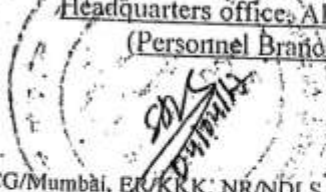

As per Railway Board's letter No.E(P&A)I-2010/SP-1/Genl.-1 dated 09.05.2012, special allowance @ Rs.2500/- PM shall be admissible to Vigilance Inspectors when their Grade Pay in their parent department, and, as Vigilance Inspector are identical.

### OTHER CONDITIONS :


1. Application duly forwarded through proper channel and filled in the enclosed-format only should be sent to this office.
2. Number of vacancies may change as per requirement.
3. Mode of selection will rest with the Vigilance organization on the basis of application / options received. Weightage would be given to the Service Record, CR, length of experience, Integrity, knowledge of computer and D&AR cases.
4. Knowledge of computer working will be given preference.
5. Extant instructions of Railway Board regarding condition of 2 years service for promotion shall be applicable.
