OFFICE MEMORANDUM

Subject: - Filling up of the posts of Senior Inspector (Technical) in the Commission of Railway Safety, Ministry of Civil Aviation.

The undersigned is directed to state that 23 posts of Senior Inspector in the Level 7 i.e. GP 4600/- (pre-revised) in the Commission of Railway Safety, Ministry of Civil Aviation are vacant. The posts are located in various region i.e. 2 posts each in 9 Circle offices of Commission of Railway Safety and 5 in Headquarter office, Lucknow. The list of offices is attached at Annexure-I.

2. The post of Senior Inspector (Technical), is to be filled as a onetime measure, pending framing of Recruitment Rules, according to the instruction laid down in Union Public Service Commission letter No.5/2(I)/2017-RR dated 21st March, 2017(at Annexure II).

3. The period of Deputation including period of Deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by Deputation shall not be exceeding 56 years as on the closing date of receipt of applications. The terms and condition during the deputation period shall be the same applicable to other railway officers joining on deputation to other Ministries/Departments. No request of withdrawal application/candidature will be entertained, once application/candidature received.

4. Ministry of Railways (Railway Board) is requested to issue directions to General Managers of all zonal Railways to circulate the 23 vacancies of Senior Inspectors, 02 posts each in 9 Circle offices of Commission of Railway Safety and 05 posts in the Headquarter office, Lucknow (list of vacancies enclosed at Annexure I) and to forward the particulars of willing and eligible officers along with necessary documents viz. Bio-data, Annual Confidential Reports of last five years (each page attested), Vigilance Clearance, Integrity Certificate to this Ministry at an early date.


