Sub: - Selection for forming a panel of Chief Law Assistant in Pay level 7 (7th PC)
(In 6th PC Pay Band 9300-34800/-+ ₹ 4600 GP) under 60% Promotional
quota for 10 vacancies.(UR-05, SC-03 & ST-02, Total-10)

It has been decided with the approval of Competent Authority to hold a selection for forming a panel against 10 vacancies including 01 vacancy of RWP/Bela. (UR-05, SC-03 & ST-02) of Chief Law Assistant (60% Promotional quota vacancies) on E. C. Railway, as per details given below:-

(B) ELIGIBILITY:-

All Permanent group 'C' employees of East Central Railway, working in Grade Pay ₹ 4200/- and below, having five (05) year non-fortuitous service in Group 'C' as on date of notification and possessing a degree in Law, irrespective of the departments are eligible to apply for the above mentioned post. RPF Personnel are not eligible for the above selection as per RBE No. 139/2003.

(C) All the volunteers who fulfill the above mentioned conditions of eligibility will be given the chance to compete in the said selection, without any restrictions to the number of eligible candidates to be allowed for appearing in the written examination.

MODE OF SELECTION

(D) The selection of above posts will be based on the candidate's performance in written examination, viva-voce and Record of Service. The candidates, who qualify in the written examination will only be called for the viva-voce. There will be no supplementary examination as this is a general selection post.

PREPARATION OF PANEL

The final panel shall be drawn up in the order of merit based on aggregate marks of 'Professional ability' and 'Record of service'. However, a candidate must secure a minimum of 60% marks in 'Professional ability and 60 % marks in the aggregate, for being placed on the panel.

Selected candidates will be posted against existing vacancies over ECR & RWP/Bela.

- (i) In the written exam, the weightage of question(s) on Rajbhasha will be 10% of total marks which will not be compulsory.
- (ii) About 50 % of the total marks allotted to the written test will consist of objective type questions. In the answer of the objective type question, cutting, overwriting, crossing, modification of answer in any way shall not be permitted.

(E) How to apply

The controlling officers should give wide publicity to this notification amongst the eligible employee under their control and ensure submission of application given by the candidates in the prescribed performa. Application given by the candidates duly countersigned by their controlling office must be submitted to concerned personnel Branch office by 31.07.2017. The filled up application should be scrutinized properly by associated Personnel Branch with the service record to avoid any factual errors and future complication and should have the counter signature of the concerned 'P' Branch officer. All the eligible applications received/scrutinized by the controlling/Personnel Branch should be sent in a bunch so as to reach Ch. OS/Admin. CPO's office/E.C.Railway/Hajipur on or before 10.08.2017 positively. Applications forwarded will not be entertained under any circumstances after 10.08.2017.
