02 SC candidates have qualified the written exam with normal standards. SC candidates under "Best Amongst Failed" scheme shall be considered only in the event of the candidates qualifying with normal standards not being found fit in requisite medical test.

On being found medically fit for the post of ACM (Gr. 'B') against 70% quota, the above mentioned candidates will be allowed to appear in the viva-voce. Candidates should be advised to keep themselves in readiness for viva-voce. The date for viva-voce will be intimated shortly.



The candidates working in Divisions/Units will be medically examined in 'SAFETY CATEGORY' for the post of ACM/Gr. 'B' by concerned CMS/MS of the divisions/units. Candidates working in HQ will be medically examined by CMS/SEE. APO/Rectt/HJP will issue Medical Memo for concerned HQ staff. Concerned Personnel Officer of the Division/units will issue the Medical Memo for the candidates of divisions/units.

Controlling Officers are advised to send the DAR/SPE Clearance certificate alongwith Medical fitness/unfitness certificate and duly completed APARs/ACRs of last five years (2013-14 to 2017-18) under their control to Dy. CPO/Gaz/HJP by 14.06.2018. positively. Concerned Personnel Officers are advised to send the Updated Service Records with Top Sheet duly filled in prescribed format indicating undergoing punishment, if any, duly signed by the cadre officer to Dy. CPO/Gaz/HJP by special messenger before 14.06.2018 .
