**NOTIFICATION**

Sub:- Re-engagement of Retired Railway employees who retired from service on or before 30.09.2018 for re-engagement against vacancies of East Central Railway, Samastipur Division on following terms and conditions.

1. Employees retired from railway service are eligible to apply.
2. The re-engagement shall be strictly up to age of 65 years or till the availability of regular candidates from RRBs/RRCs of any other mode or validity of the scheme i.e. 01.12.2019, whichever is earlier as per Railway Board's letter no. E(NG)/II/2007/RC-4/CORE/1 dated 16.10.2017 (RBE No.150/2017 and RBE No. 193/2017).
3. The administration is at liberty to terminate the service of the re-engaged employees even before 01.12.2019 in case their work/conduct is found unsatisfactory or due to any other reasons.
4. In this scheme, Railway employees who are compulsorily retired or removed or dismissed from services and also retired voluntarily under SRSS and LARSGESS are not eligible to apply.
5. The monthly remuneration of the re-engaged retired employees will be determined by reducing pension from his/her last pay drawn (i.e. Basic Pay +DA) and no other allowances/remuneration shall be payable in terms of Board's letter No. E(NG)II/2007/RC-4/CORE/1 dated 16.10.2017 (RBE No. 150/2017 and RBE No. 193/2017).
6. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
7. Suitability/competency of the applicant shall be adjudged by a duly Constituted Committee for re-engagement and issue of their safety record as well as the safety and other operational requirements as needed are adequately addressed.
8. Re-engagement shall also be subject to prescribed medical fitness for the Cadre in which they are to be engaged.
9. Posting of selected candidates within Departments of Division of East Central Railway, Samastipur would be decided by the competent authority. Selected candidates would be required to join within 10 days of their selection result being published, failing which their selection is liable to be treated as cancelled.
10. The normal Duty Hours of re-engagement employee would be the same as applicable to other similarly placed staff.
11. The re-engaged retired staff may be permitted off on Sundays and National Holidays. However, they may be called for Duty on any Day including Sundays and National Holidays for which Compensatory Rest may be given later. In addition, Re-engaged retired Staff may be granted 02 days leave for each completed month of engagement in Railway. The accumulated leave will lapse as soon as the Contractual period is over and cannot be carried over to next contract(If any).

  - (i) Pensioner Identity Card
  - (ii) Pension Payment Order
  - (iii) Last Pay Slip
  - (iv) Savings Bank Account Pass Book
  - (v) Six copies of recent passport size colour photos (not older than 03 months).
  - (vi) Aadhar Card
  - (vii) Pan Card
13. The last date for submission the application is 24.10.2018.


