CPO/Gaz/HJP by 12.04.2019 positively. Concerned Personnel Officers are advised to send the Updated Service Records with Top Sheet in prescribed format indicating undergoing punishment, if any, duly filled and signed by the Cadre Officer to Dy. CPO/Gaz/HJP by special messenger by 12.04.2019.
