PM-SYM is a pension scheme for the workers in the unorganized sector, such as street vendors, sanitation workers, rickshaw pullers, construction workers, domestic workers, rag-pickers, agricultural workers, beedi workers, cobblers, handloom workers, washer-men, leather workers or those engaged in other similar occupations and whose monthly earnings are Rs.15,000/- or less. The scheme has been introduced under Section (1) (c) of the Unorganized Workers' Social Security Act, 2008 which mandates the Government to formulate and notify suitable welfare schemes for unorganized workers on matters relating to old age protection:

2. PM-SYM is a voluntary contribution based pension scheme. All workers in the unorganized sector between the age of 18 and 40 years with monthly income of Rs.15000/- or less are eligible to join the scheme provided they are not member of National Pension Scheme, EPFO, ESIC and not an income tax payee. After attaining the age of 60 years, a worker would be entitled for minimum monthly assured pension of Rs.3000/-. The scheme envisages equal matching contribution every month is made by the Central Government. The enrolment process for the scheme is very simple and the pre-requisites are that a worker has an Aadhaar Card and Savings/Jan-Dhan Account passbook with IFSC code. Ministry of Labour and Employment has on-boarded Common Service Centres under the aegis of Ministry of Electronics and IY (MeitY), as an enrolment agency for the scheme of PM-SYM. The nearest CSC can be located through the link locator.csccloud.in

3. A copy of the Scheme Notification, key features and enrolment process are enclosed for your ready reference.

4. There are large number of workers, such as porters, platform vendors, koolies, sweepers, safai karmcharis, etc. in Railways. I would request you to kindly take up the matter with concerned authorities, trade unions and educate them about the Scheme to facilitate enrolment of such workers under the PM-SYM scheme so as to provide social security to such unorganized workers in their old age.
