

Concerned Controlling Officers of Unit are also advised to send the updated Service Records with TOP SHEET in prescribed format indicating undergoing punishment, if any, duly filled and signed by the Controlling Officer of Unit by special messenger to SPO/Con/MHX by 10.12.2019.
