Ref: This office letter no ECR/ADM/Rly.Quarter/policy/002 dated: 29.05.2019.

Earlier revised policy for allotment of Railway Quarters to Officers of ECR/HQs was issued vide this office letter No ECR/ADM/Rly.Quarter/policy/002 dated: 29.05.2019. Now modification in para-6.2 & 6.3 has been done which is appended below.

Details of modification in Para -6.2 & 6.3 are as under (underlined item in existing Paras have been deleted):-

SAGs SG/JAG (Confirmed with more than 3 years service in grade) <p>(b) When these quarters/bungalows are available for allotment & none of the above Officers are either in waiting list nor willing to occupy them, the same will be allotted to other JAG Officers.</p> <p><u>Whenever type-VI quarter is vacant & the officers concerned is in occupation of quarter, of below the entitlement, he/0 may be requested to occupy type-VI. On his refusal, to occupy the same, SAG next in priority will be allotted type-VI quarter.</u></p>	<p><u>Type- V quarters</u> (a) Priority of allotment will be</p> <ol style="list-style-type: none"> All PHODs/CHODs including CSO & SDGM, will be allotted out of turn. SAGs SG/JAG (Confirmed with more than 3 years service in grade) <p>(b) When these quarters/bungalows are available for allotment & none of the above Officers are either in waiting list nor willing to occupy them, the same will be allotted to Adhoc JAG Officers.</p>
