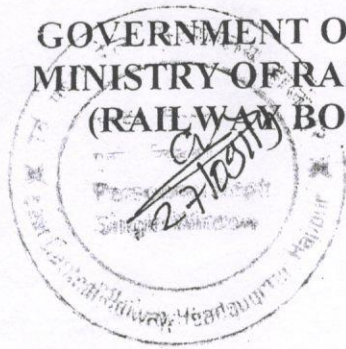

Sub : - Issuance of orders on establishment matters by other Departments.

Recently, it has come to notice that orders enhancing the quantum of allowances introduced by 7th CPC for one of the categories of Indian Railways had been issued by Engineering Department of one Railway even though no such circular had been issued by the Railway Board to any Zonal Railway or Production Unit. Though, the orders were withdrawn subsequently, it had led to an embarrassing situation resulting in confusion among staff.

2. This incident has been noted seriously. It is advised that any policy circular on establishment matters be issued only by the Personnel Department of the concerned Railway/units duly taking finance concurrence, wherever required on the file of the Personnel Department.

3. Necessary instructions may be issued to all PHODs in the matter.
