Sub: 65th Railway Week National Awards, 2020 – Railway Board's level.
Ref: Railway Board's letter No. 2019/O&M/12/4 dated. 13.12.2019

65th Railway Week National Awards will be celebrated from 10th to 16th April, 2020. During the central function of Railway Week, cheques/Silver Medals/Merit Certificates are presented to those Officers/Staff who are selected for Railway Week National Award for their exemplary, outstanding and meritorious performance.

2. Please send your recommendations in respect of officers/staff working on your division/unit to enable consideration of their names for grant of Railway Week awards during the Central Function. While making the recommendation, the following points should be kept in view:

- New innovations/processes/procedures leading to economy in expenditure, improvement in Productivity, import substitution, etc.
- Meritorious Acts even in disregard to personal safety leading to protection of life and property on Railways;
- Special efforts made to increase earnings/tackle ticketless travel, theft, increase in loading/ saving in expenditure etc;
- Exemplary work done to improve operation, Security and Safety, better maintenance and utilization of assets;
- Completion of projects etc in record time;
- Outstanding performance in the field of sports, leading to National/International recognition.
- Outstanding performance in any other field.
- Nominations be made for the work done upto December 2019, only.

2.1 As Railway Week MR Award is the highest prestigious award, it is requested that only really deserving cases be recommended for Railway Week MR Award.

3. Group "C" and erstwhile "D" categories of Railway staff may normally benominated. In exceptional cases, officers upto JA Grade/Selection Grade, who have done exemplary work, may also be nominated. The names of Officers above Selection Grade will not be considered under any circumstances.

3.1 Further, no recommendation for Group Award should be sent as Group Award are neither considered nor given during the Railway Week Central Function.

3.2 The names of those officers/staff who have received the Railway Week MR award in the past should not normally be nominated again except in case where some exemplary commendable performance has been shown by the employee. An undertaking in this regard as per Annexure-III is to be invariably obtain from the concerned staff that in the past whether he/she has received /been selected for Railway Week National Award or not. Nomination without undertaking will not be processed.

4. Details of service in the prescribed proforma enclosed at Section-I & II together with a brief citation (half-a-page maximum) bringing out the specific outstanding work/performance, for which the person is being recommended, may be sent in **four copies**. Besides four big size colour photographs should be pasted at the place indicated in the proforma (Annexure-II). It should be ensured that the persons so recommended do not figure in D&AR and/or Vigilance case(s). It should also be ensured that no abbreviations are used and no column is left blank while filling in the proforma.

5. Your recommendations in sealed cover may please be sent to concern PHOD with a copy to DyCPO/IR&W, ECR/HJP on or before 10.01.2020. Recommendations received after 10.01.2020 will not be considered for the above award.



ANNEXURE-I

**Guidelines for Sending Nominations For Railway Week National Award, 2020
(For Railways/PUs & Other Units)**

- I. Category under which Nomination to be sent:-
 - (a) New Innovations/processes/procedures leading to economies in expenditure, improvement in productivity, import substitution etc;
 - (b) Meritorious acts even in disregard to personal safety leading to protection of life and property on Railways;
 - (c) Special efforts made to increase earnings and to tackle ticketless travel, thefts, etc;
 - (d) Exemplary work done to improve operations, security and safety, better maintenance and utilization of assets;
 - (e) Completion of projects etc. in record time;
 - (f) Outstanding performance in the field of sports, leading to national/international recognition.
 - (g) Outstanding performance in any other field.
- II. One official be nominated for only one category.
- III. Brief Citation/write up in respect of category under which nomination(s) is being made be indicated in the proforma at relevant columns. **Nominations be made for the work done upto December 2019 only.**
- IV. **Nominations should be made only in favor of Officers/Staff working in the field, unless an exception in real sense could be made in respect of Officers/ Staff working in Offices.**
- V. Group 'C' and erstwhile Group 'D' categories of Railway staff may normally be nominated. In exceptional cases, Officers upto JA Grade/Selection Grade, who have done exemplary work, may also be nominated. However, officers above the Selection Grade may not be nominated as the scheme does not cover them.
- VI. No recommendation for Group Award be sent as Group Awards are neither considered nor given during the Railway Week Central Function.
- VII. Railway Week National Award is a life time award, as such names of those officers/staff who have received the award once in the past should normally not be nominated again except in case where some exemplary commendable performance has been shown by the employee. An undertaking in this regard as per **Annexure-III** is to be invariably obtained from the concerned employee that in the past whether he/she has received /been selected for Railway Week National Award or not. **Nomination without undertaking will not be processed.**
- VIII. In the forwarding DO letter/letter from Railway, it should be clearly indicated that no D&AR and/or Vigilance case(s) is/are pending against the concerned employee. Details for each and every nominee be indicated separately. It is also clarified that if there is any change in the Vigilance/D&AR status of the nominee in the intervening period between the date of sending nominations to the Board and the date of award, the same may also be advised to this office. If no report is received in this regard during the intervening period, it will be presumed that the status indicated earlier remains same.
- IX. Three passport size colour photographs (minimum 3.5 x 4.5 cm) should be pasted at the place indicated in the proforma.
- X. No abbreviations should be used and no column be left blank while filling the proforma.

- X. Details of the pay level (as per 7th Pay Commission) of the nominee should be clearly indicated. In addition with regard to Gazetted Officers, their Grade (Gr 'B'/Jr. Scale/Sr. Scale/JAG/SG) should invariably be indicated.
- XI. **Contact Details viz. Mobile number of the concerned employee(nominee) and his next immediate higher official should invariably be indicated** so that the employee may be contacted/informed in case his/her name is selected for award or in case any information is required in connection with processing of award.
- XII. Duly filled nomination form/proforma along with declaration at Annexure-III be sent in triplicate.
- XIII. **Maximum number of nominations to be forwarded are as under:-**

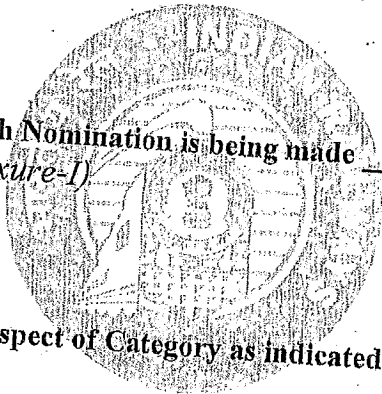
