

It has been brought to Board's notice from certain quarters including NFIR that in the AVC of Radiographer/X-Ray Technicians, the educational qualification for the post has been mentioned wrongly. The inadvertent error in this regard stands corrected and the prescribed educational qualification for the said post as mentioned therein may be read as follows:-

- (i) 10+2 or equivalent examination passed with Science subjects from a recognized Board; and
- (ii) Radiographer/X-Ray Technicians course of minimum one year duration (including in field training in diagnostic radiology) passed from a recognized institution.
