



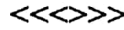

With the approval of the competent Authority, it has been decided to conduct Appendix-4(IREM) examination of following prob. Stock Verifier over this railway:-



1. The examination will be guided by the instructions contained in Railway Board's letter no. 2000/AC-II/20/23(Vol-I) dated: 22.09.2009 & Appendix-4 of IREM Vol-I.
2. The examination will be conducted for confirmation on the post of Stock Verifier. The persons selected for promotion to the rank of Stock Verifier and have completed at least one year of satisfactory officiating service as Stock Verifier are eligible to appear in this examination.
3. The Appendix-4(IREM) exam will be such as to test the general familiarity with the various classes of stores and procedure followed in the Stores Depots and in the Accounts Office, and the practical knowledge of the procedure relating to the verification of stock and stores, adjustment arising from such verification and preparation and disposal of stock verification reports.
4. The examination will consist of a written paper and viva-voce test and 50% of the maximum marks in the written paper as well as the viva voce test will be required to secure a pass. The paper of written examination will constitute 100 marks and Viva-voce test will be of 50 marks.
5. The examination is scheduled to be held on 30.04.2020 (Thursday) from 11:00 to 14:00 hrs at PFA office, Old GM building ECR, HJP.

6. It is requested that this notification may be given wide publicity among the staff and application of willing and suitable staff may be forwarded to this office within 10 days from issue of this notification in enclosed Proforma (i.e. Annexure 'A').
7. Controlling officers are also requested that the staff(s) working under your control must be relieved well in time with proper identification for appearing in the above said examination.


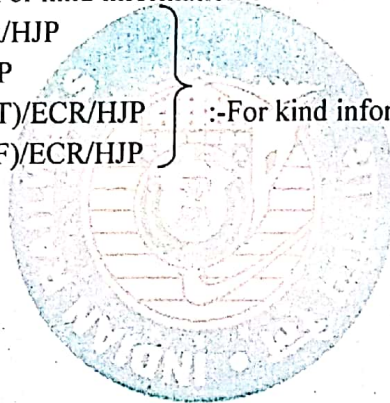
