❖ **Passenger Security awareness-**

Time to time Passenger awareness programmes are organized at all important Railway stations against menace of drugging, Pick pocketing and theft of passenger belongings, Security helpline no.-182, women child security, footboard travelling, stone pelting, ACP etc.

❖ **Passenger Security Helpline :-**

During the period April 2019 to March 2020 total-**128** complaints were received through help line number-182, regarding Theft of passenger belonging, Nuisance, Unauthorized entry etc. On receipt of these complaints, concerned RPF Post immediately attended and solved the problems and obtained feedback from the passengers. All complainants were fully satisfied with the response of RPF.

❖ During the period April 2019 to March 2020 total number of **7205** Mail/Exp. trains were escorted by RPF from existing resources. No serious nature case have been reported in escorted trains.

❖ During period April 2019 to March 2020 total **1031 persons** were arrested and booked under section 141 of the Railway Act, against unauthorized chain pulling in running trains. Due to regular drive against unauthorized chain pulling in running trains and escort of Mail/Exp trains the cases of unauthorized chain pulling is being reduced and under control.
