

Please find enclosed herewith the above referred letters in which option have invited for those Railway Servants whose final results for appointment have been published before 01/01/2004 but joined after 01/01/2004 may opt for Old Pension Scheme.

Railway Board has given one time option to all NPS staff whose final results have been issued prior to 01/01/2004 for appointment against the vacancies occurring on or before 01/01/2004 but joined on or after 01/01/2004 may now opt the benefit of Old Pension Scheme under Railway Service (Pension) Rules. The option may be exercised by the concerned eligible Government Servants latest by 31/05/2020. The option once exercised shall be final. The eligible Government Servants who do not exercise option by the stipulated time i.e. 31/05/2020 shall continue to be covered by the Nation Pension System.


Option of eligible Railway Servants to switch over from NPS to OPS alongwith necessary documentary proof duly forwarded by the respective Officers/Office In-charge may be sent to DRM (P)/SEE Office (Single Window System) latest by 31/05/2020. No option shall be entertained after 31/05/2020 in any circumstances. Option form is enclosed as Annexure-A.
