Board's letter No. F(E) II/89/FR-I/I, dated-12.12.1991 amended to IREC Vol-II (VI edition-87). If no option is exercised within a period of one month from the date of issue of this order, the pay shall be fixed under Rule 1313 (FR-22) R-II and also guidelines given for pay fixation in Railway Board's Letter No. F(E)II/2003/FOP/I(Misc.) dated-28.01.2020(RBE No. 12/2020) will be referred where applicable.
3. While fixing the pay for those employees who have already been availed the benefit of pay fixation on grant of financial upgradation under MACPs, the instructions given in RBE No.113/2017 dated-30.08.2017 and RBE No. 23/2019 dated-12.02.2019 will be followed.
4. Those employees who got the benefit in Level-9 under MACPs after due date of NFU the pay may be fixed from the due date of NFU as per para 2 above.
