**Re-engagement of Retired Officials of State Government through  
walk-in interview**

In terms of Railway Board's Letter No. E(NG)II/2020/RC-4/2(Pt.2) Dated 22.02.2022(RBE No. 23/2022), it has been decided to re-engage retired officials of State Government of revenue department of Bihar/Jharkhand State in any Grade Pay through walk-in interview as Consultant(Land Liaison) in Construction Organization, E.C.Railway purely on contract basis for Job related to survey, updation of land records and to co-ordinate with State Govt. agencies for different activities involved in land acquisition.

- The re-engagement will be offered purely on contract basis up to 21.02.2023 or till the task is completed or till the time the contracted person attains 65 years of age, whichever is earlier.
- Requirement of retired State Revenue Department officials in Bihar/Jharkhand State in any Grade Pay is as under :-

Note : \* Requirements shown above are provisional and may increase and decrease at later stage depending upon the actual needs of Railway Administration.

- Age limit:** All those less than 64 years of age as on date of notification can apply.
- Applicant's eligibility:** Only Retired State Govt. Officials (All Grade) from Revenue Department of Bihar/Jharkhand are eligible. These Revenue Department retired Officials must have dealt with the work related to survey, updation of land records and co-ordination with State Government agencies for different activities involved in land acquisition during their tenure in concerned State Government. Removed/Dismissed/Compulsorily retired employees are not eligible for re-engagement.
- Mode of Selection:** Suitability/Competency will be judged by walk-in interview.
- Remuneration, Allowances and Leave:**
  - A fixed monthly amount will be admissible as remuneration during the contract period, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract.
  - No increment, Dearness Allowance and HRA shall be allowed during the term of the contract.
  - An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed will remain unchanged during the term of appointment. However, they may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
  - Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service.

8. The selected candidate has to undergo medical examination for medical fitness of the appropriate category from the designated authorities as per existing practices.
9. The integrity aspect will be checked before re-engagement.
10. **Agreement:** The re-engaged retired employees have to sign an agreement of confidentiality with the Railway containing a clause on Ethics and Integrity.
11. The retired employees selected for re-engagement shall strictly abide by all the terms and conditions of the re-engagement scheme from time-to-time.
12. **Termination of contract:** The contract may be terminated by either side by giving 15 day's notice. The performance monitoring of retired re-engaged State Government staff shall be done on regular basis and those who are unable to discharge the duties or who fail to perform as per expectations of the administration, may be given 15 day's notice and their contract will be terminated. However, in case of any adverse report regarding the integrity/gross negligence/misconduct/irregularities etc, the engagement may be terminated with immediate effect.
13. The Railway Administration has right to transfer re-engaged officials within jurisdiction of E.C.Railway in administrative exigency.
14. The re-engaged officials should remain be medically fit, the medical fitness will be judged by the Medical Department of Railway.
15. The re-engaged official shall not divulge any information gathered by him or her during the period of assignment related to the organization to anyone who is in not authorized to know or possess the same.
16. The candidates should report for walk-in interview with all original documents along with PPO and duly filled up form attached with this notification at the time and venue mentioned above for walk-in interview.
17. All these re-engagement on contractual basis will be dealt with as per Railway Board's Letter no. E(NG)II/2020/RC-4/2(Pt.2) Dated 22.02.2022(RBE No. 23/2022) and read with modification issued by the Railway Board time to time.
18. Any subsequent changes in the terms and conditions of the Notification as per extant rules will stand good. ECR/Construction Organisation reserves the right to consider/incorporate any subsequent changes/modification/additions/cancellation in the terms & condition to re-engagement under this notification as and when applicable.
19. For any Legal Dispute, the Jurisdiction will be Central Administration Tribunal, Patna only.
20. ECR/Construction Organisation reserves the right to reject the candidature of any applicant at any stage of re-engagement thereafter if any irregularity/deficiency is noticed in the application.
