It is known that NAIR/Vadodara is going to hold CBT for the post of APO (Gr. 'B') in 2nd shift on 20.11.2022 at the centre as stipulated in NAIR's letter dated 04.11.2022 under reference- 2.

As per information received from NAIR/Vadodara, it has been seen that uploading of photograph and downloading of E-call letter as well as E-relieving letter by the eligible staff is very poor.

As the examination for CBT is very close i.e. 20.11.2022, as such all concerned controlling officers are advised to direct their staff to upload the photograph and download E-call letter as well as E-relieving letter and ensure relieving of staff for the said CBT well in advance without fail.

It is also intimated that the concerned staff will not be allowed to appear in CBT exam without the desired documents as mentioned in NAIR's letter under reference- 2.
