

On being found medically fit for the post of APO (Gr. 'B') against 30% quota, the above mentioned candidates will be allowed to appear in the viva-voce. Candidates should be advised to keep themselves in readiness for viva-voce. The date of viva-voce will be intimated shortly.

The candidates working in Divisions/Units will be medically examined in 'NON SAFETY CATEGORY' for the post of APO (Gr. 'B') by concerned CMS/MS of the Divisions/Units. Candidates working in HQ will be medically examined by CMS/SEE. APO/Recruitment/HJP will issue Medical Memo for concerned HQ staff. Concerned Personnel Officer of the Division/Units will issue the Medical Memo for the candidates of Divisions/Units.

Controlling officers are advised to send the DAR/SPE clearance certificates alongwith Medical fitness/unfitness certificate and duly completed APARs/ACRs of last five years of the shortlisted candidate(s) under their control to Dy.CPO/Gaz/HJP by 08.12.2022 positively.
