Sub: Selection for the post of **Chief Vigilance Inspector/Engg** in Pay Matrix Level-7 (scale of Rs. 9300-34800 in Grade pay of Rs. 4600/- in 6th CPC) in Vigilance Organization of East Central Railway, Hajipur.

In order to fill up ex-cadre post of **Chief Vigilance Inspector/Engg.** in Level – 7 (scale of Rs. 9300-34800 with grade pay of Rs. 4600/- in 6th CPC) in the vigilance Organization, E.C.Railway, it has been decided to hold a selection for forming a panel of **Two (02) candidates** from the technical staff of Engineering Department. The tenure of the post will normally be for three (03) years, which may be curtailed/extended as per extant rules.

Eligibility:

- (i) Staff belonging to the Engineering department in Railways working as SSE/SE (P.Way/Works/Bridge/Drawing) in Level – 7 (scale of Rs. 9300-34800 with G.P. Rs. 4600 in 6th CPC) or one scale below i.e. in Level – 6 (scale of Rs. 9300-34800 with G.P. Rs. 4200/- in 6th CPC) on regular basis on the date of notification.
- (ii) The staff should have completed at least five years service in Railways as on date of notification.
- (iii) Staff who has already completed his tenure in the Vigilance Organization of Zonal Railways/Units/Railway Board earlier as Vigilance Inspector/Investigating Inspector (Vig.) is not eligible.
- (iv) The integrity of staff should be beyond doubt. Staff should have clear Vigilance history and should not have undergone any penalty in Vigilance/SPE case. Also the staff should not have undergone/undergoing any penalty under DAR in the last 3 years.
- (v) Working knowledge of computer is essential.

The selection will comprise of a written test followed by a Vigilance Aptitude and Computer Knowledge Test. Questions in written test may be asked from R.S. (D & A) Rules, 1968; R.S. (Conduct) Rules, 1966; Establishment matters, Rajbhasha, General awareness and Codes, Manuals, matters pertaining to the Engineering department etc.

Wide publicity of the above vacancy notice may kindly be given and this should also be displayed prominently on notice boards for information of the staff.

Application of those employees who have not undergone any penalty in Vigilance/SPE case during their service period and employee who have not undergone any penalty under DAR in the last 3 years, should only be forwarded. It must be ensured before forwarding the application, that the applicant is fulfilling the eligibility criteria.

Application of the eligible volunteers duly filled up in the enclosed proforma and forwarded through **proper channel** may be sent to **G.M (Vigilance), East Central Railway, Vigilance Department, Hajipur, Dist.-Vaishali, PIN-844101**. It may be ensured that only the application of staff having proven integrity are forwarded.
