Sub: Provision for sports infrastructure development in sanctioned estimates.

The matter of utilizing relevant provisions in sanctioned estimates for sports infrastructure development was under consideration in Board.


2. It has now been decided by Board (MF) to authorize DRMs for sanction of sports related works upto Rs 1 Cr. Beyond Rs 1 Cr and upto Rs 2.5 cr, these works will be sanctioned by General Managers.

3. Accordingly a new Para 2(E) has been inserted for sports development works in Part-A "Works Matters" of Model SOP as mentioned below:
