Sub: Revision of format of MCDO to be sent by depots every month to HQ

The current format of MCDO being sent by depots every month to HQ has been reviewed and it is decided that the format of MCDO be changed in line with Stores Shield Criteria and other relevant parameters and accordingly following instructions are being issued:

- 1. The format of MCDO has been revised and is being attached herewith as Annexure-A. The format has been filled with some dummy data for better understanding.
- 2. The medium of submission of MCDO shall be e-file. An e-office file shall be created by respective depots with the title "MCDO of <u>DEPOT\_NAME</u> (Depot Code <u>XX</u>) to be submitted to PCMM Office on 5th of every month". The e-office file shall be returned to respective depots by middle of every month along with actionable points/ suitable instructions from the office of PCMM.
- 3. The pdf of monthly MCDO is to be attached in the corresponding side and the file is to be submitted to PCMM through Secy. to PCMM.
- 4. MCDO for the month of June, 24 may be submitted by 10th July, 2024. MCDO from next month onwards to be submitted by 5th of every month.
