The following transfer and posting order is issued on administrative ground with immediate effect :-



• They should vacate the Rly. Qtrs., if any, under their possession while proceeding on transfer, Permission for retention of Railway Qtrs. as admissible under rule can be given provided they make a request and their request are considered, failing which damage rent will be recovered from their salaries for un-authorised occupation of Rly. Qtrs. and they will be liable to be taken up under D&A rules.

• As above transfer orders are on Administrative Ground, Admissible benefits, as per rule, may be extended to all of them.
