SUB:- Proposal of System Improvement.

In Course of vigilance check, ticket checking staff are found discharging their duty without proper/valid travelling authority and checking authority which need to be validated by the last date of December in every year. In terms of para 919 of IR code for traffic (Comml.), it is essential for ticket checking staff to carry valid travelling and checking authority while performing duty.

To avoid the delay in validation of the above authorities, an arrangement to feed the validity of travelling authority as well as checking authority should be made in TTE Lobby Application, presently being used by ticket checking staffs to sign on/sign off the duty. As a result, this application would prevent TTEs from signing on/signing off whose travelling/checking authority's has got expired as CMS (Crew Management System) prevents the Crew & Guards from signing on/signing off the duty in case of PME & Refresher course of the respective crew & guards being due.

Further, 07 days grace facility may initially be provided only when remarks of delay from the competent authority of divisional HQ has been obtained and feeded manually in the TTE Lobby Application. It should be the responsibility of the supervisor that renewal/validation of above authorities should be started a month in advance i.e December and completed by the end of the month. Until the renewal process is completed and the travelling authority/checking authority is returned to the concerned staff, the acknowledgment copy issued during submission of the original authority for renewal may be treated as valid authority.

Kindly take necessary action accordingly under intimation to this office.

Sub: Preventive check conducted at Parcel office/ MFP on 08.09.2022.

In course of a vigilance check conducted by vigilance team of ECR at Parcel office/MFP on 08.09.2022, it was noticed that separate personal cash register was being maintained by different section of Parcel Office/MFP (In ward parcel, out ward parcel etc.). It is pertinent to mention here that the personal cash register should be maintained in such a way that every unit of a station such as Reservation Office/PRS, Booking Office/UTS, Parcel Office, Goods Shed, and CIT Office has one separate personal cash register. Keeping separate personal cash register for different sections of one unit will defeat the very purpose of declaration of personal cash before taking up of duty as due to this there is probability of breaching transparency and continuity.

In light of the above, it is requested to issue a System Improvement Letter (SIL) to all divisions of ECR to maintain unit wise personal cash register.

Shri Sanjay Paswan s/o Shri Jailal Paswan a contractual staff of Ms. Jai Mata Dec retired Employees Association, W.S. 5/56, Upper Police Chowki, Kankarbagh, Patna-20 who was found working as ACCA of B-3 of Train No. 12309 on 14/15-5 2016 (ID-114) under SSE (Elect)/AC/RNCC, Patna, found responsible for accepting Rs. 3000/- illegally from a without ticket passenger which he produced during the vigilance check and same was returned to the passenger with intervention of Railway Board Vigilance. Railway Board has advised that Shri Sanjay Paswan should not be utilised in any train escorting duty in future also, if he is still working over ECR.

Further, Board has also suggested that ECR should consider to insert suitable provisions in the Contract Agreements, which has not been included so far, the penal action to be levied against the firms and the contractual staff, if any irregularity is committed by their outsourced employee during the trains duties.

In light of the above it is herby proposed to take appropriate action over the issue with intimation to this office in regard to action taken so that

Railway Board can be appraised accordingly.
