1	The Depot is full of materials. A lot of ALCO items are yet to be shifted to SPJ as directed earlier. Depot will expedite the shifting process as a road contract for transportation is also being finalized by Sr.DMM/DHN shortly. Before shifting all the ALCO items, all these items be put up to survey committee to weed out and dispose those items at PTRU itself which have deteriorated due to prolong storage or any other reason or have become obsolete or unusable. Only usable items be sent to SPJ. Damaged/overaged filters/gaskets should be disposed of immediately.	Sr.DME/PTRU Sr.DMM/DHN AMM/PTRU
2.	Many unaccounted material/non-stock items not purchased through stock were also noticed inside the ward. All such items to be taken in stock through DS-8 (CC-48) or SA account (CC-49) to account for. Thereafter, based on condition, the same may be put up to survey committee for disposal. 3	Wheel Lathe which is not in use for long may be examined for condemnation. One HHP Loco no.70159 was reported not fit for movement and use. The same may be examined for premature condemnation.	PCEE Sr.DME/PTRU
4	Inside the Shed premises, large amount of scrap/worn-out components were seen. Sr.DME/PTRU should offer all these items immediately for scrap sale. The shed should become scrap free before 31.03.2025.	Sr.DME/PTRU Sr.DMM/DHN AMM/PTRU

8	There is no utility vehicle for AMM/PTRU. The same may be proposed so that local purchase collection/scrap mapping in different stations/locations may be done effectively.	1

The location on the same side of road besides the RCD was finalized for creation of new warehouse of the depot. The drawing is to be made in such a manner that the depot has mechanized material handling facilities requiring less number of man power.
