Sub: Procurement of VHF radio set by Indian Railways.

Ref.: Letter no RDSO-Tele0LKO(Tech)/8/2020 dated 26-07-2024.

Vide letter under reference, PoC guidelines of certain telecom items were issued by RDSO and VHF radio is also part of it. Being the user of VHF radio, it is mandatory that regulatory guidelines issued from time to time by Govt. of India should be followed.

In view of above it is requested to take the mandatory regulatory certifications i.e. MTCTE certification and WPC certification applicable to 5W and 25W VHF radio from the bidders while procuring the Walkie-Talkie sets.

For those cases, where the tenders are yet to be opened or yet to be finalized, the bidders shall be asked to submit these certificates within 15 days. Furthermore, the tenders shall be finalized only after receiving these certificates. For all new procurements, submission of these regulatory certificates shall be mandatory.

This has the approval of PED/S&T/RDSO.
