

- There should be facilities for 2D/3D/4D including special software for foetal echo. iii.
- Panoramic imaging desirable for elegant Musculoskeletal work.
- D. Mammography: high resolution digital mammography with compression device and a fully legal CR (Computed Radiographic) capability recognized in other countries.
- E. X-Ray: AERB Approved, minimum 500 mA or more x-ray with image intensifier and image output by good quality high resolution DR or CR system for digital output of the image and backed by a good laser camera. For Cardiology: Lab Should be equipped with minimum 12 channel ECG Machine and TMT-ECG Machine.

Note: The qualifying criteria, specifications and Technology/Machineries required for a Diagnostic Centre to be empanelled are framed as wholesome criteria but diagnostic center which does not meet criteria of any particular investigation and technical suitability, they will be considered for the investigation and investigation done by other diagnostic modalities, exempting them for diagnostic facilities which they don't have.
