The records of the discussion and decisions are as under: -

SN	Decisions Taken	Action by
1	<p>RWP Bela needs about 10000 MT of Scrap Rail and about 6000-7000 MT of ERCs every year for use in their foundry. ECR have to supply these being the nearest Railways.</p> <p>At present orders for 1000 MT of Scrap Rails from SEE and 2400 MT of ERCs from all divisions are already placed by RWP on ECR. However, the dispatches are extremely poor due to different reasons and only about 25 MT of ERCs have been supplied to them till now since Jan-25.</p> <p>Modalities for expeditious supply of these items was discussed in details and following is instructed.</p>	All Sr.DMMs
2	<p>The supply of Rails will be affected as below:</p> <ol style="list-style-type: none"> POs will be placed by RWP/Bela as per extant procedure. PCMM/RWP may place orders for balance Qty of their annual requirements of Scrap in next 10 days to ECR. RWP/Bela may identify Condemned Scrap Rail lots of ECR(published/ unpublished), which they want to lift.Based on such identification, SROs shall be issued by SrDMMs of Divisions. The supply will be made from PWIs site. Cutting and transportation will be done by RWP/BELA. After issue of SROs, RWPwill immediately apply to concerned SrDMM for permission to cutting (if required in case Rail pieces are long and unloadable on trucks) and fixing of delivery program. SrDMMs will unpublish the lots (if required) and permit them for cutting by giving directions to PWIs and after cutting the Rails they will fix up the delivery Program as per extant procedure. Based on the delivery Program, the Rail will be delivered to RWP Bela as per existing procedure duly witnessed by SV and RPF and the authorized representative of PCMM/RWP. Sale issue Note shall be made as per existing procedure. 	All SrDMMs All SrDENs DyCE/Track/ECR

	f) After receipt of the materials at Bela, a confirmation may also be given to concerned SrDMM by the office of PCMM/RWP/Bela.	
3.	<p>The procedure for supply of ERCs will be as follows:</p> <p>a) Trucks from PWIs are coming empty from different PWIs of SEE/SPJ/DNR divisions for collection of materials from GSD/GHZ.</p> <p>b) Hence forth, PWIs of these division may send the Scrap ERCs/ Not Bolts/ Fishplates/ Other small Track items on online DS-8 in UDM (well established procedure) to GSD/GHZ, whenever they send the trucks for collection of materials from GHZ. The DS-8/ materials shall be acknowledged and accounted for by GHZ as per extant procedure.</p> <p>c) GSD/GHZ will deliver the Scrap ERCs and other Scrap items required by RWP following extant procedure.</p> <p>d) For DHN/MGS divisions, the items may be delivered from PWIs site as per procedure mentioned at SL-1 (except cutting requirements) for time being till further orders. However, they are also permitted to send such items to GSD/GHZ through trucks.</p>	All SrDMMs All SrDENS DyCE/Track/ECR
3	Condemned Casnub bogie of ROH/BRWD and WCC/DDU be sent to RWP/Bela by direct sale as per existing procedure. AMM/BRWD and AMM/DDU may open a scrap Card and effect delivery of the item after transacting the items from SSE/Wagon and then giving delivery from the stock on DS-8	SrDMM, SrDME/DDU-DHN AMM/BRWD, AMM/DDU
4	Coaching Bogie of CRW/HRT is not required at RWP/Bela. Hence, it may be e-auctioned by Dy.CMM/HRT till further orders.	Dy.CMM/HRT
