- 3. Existing Procedure of RP fixation by ACOs, shortcomings and system improvement.
- 4. ACOs to come prepared with PPT on following topics:
 - a. Layout plan, progress and time line, bottlenecks of existing work sanctioned.
 - b. Requirements of new works under umbrella.
- c. Revenue fund arranged under different heads in 2025-26 and expenditure thereof.

Sr.DMM/DHN & Sr.DMM/DNR had not attended the meeting due to the exam duty. They have been told to come at HQ/HJP at an early date jointly and present the above agenda.

ACOs to follow the same strictly to avoid any post auction litigation. The lot may be got visited/ surveyed if required and RP be fixed thereafter.	
4	Considering few lot specific situations, ACOs may allow dismantling or cutting or decanting or segregation or hammering or breaking as well as lifting direction. ACOs are advised to get such lot surveyed before publishing the same and suitable condition regarding above must be mentioned in auction condition at the lot publishing stage itself.	All ACOs
5	ACOs to mention the end from where the scrap is to be delivered in case of big lot of mixed materials, so that picking/ choosing is avoided.	All ACOs
5	If scrap materials of same/similar types is spread over significant area and not in continuity, then the same may be included duly making sub-lots which may save significant time and revenue in shifting. Such sub-lots be clubbed under a single lot. In such cases, the sequence of delivery among sublots must be stipulated.
