6. It should be confirmed that the money has been deposited by the party before incurring expenditure from the head deposit head.
7. Strict compliance of the revised guidelines issued vide Board's Letter no.2023-B-322(NBO) Dt:-21/04/2023.
8. All are requested to analyze cash projection against availability of fund. The final requirement of ex-chequer under each segment may be submitted to HQs positively by 15th to 20th of the concerned month. No request for additional ex-chequer received after 20th will be considered.
